**Terms and Conditions of Entry\***

*\*Information on how to enter and prizes form part of these Terms and Conditions.*

**1. Eligibility:** Entry is open to all current and financial GU Health members who are aged 18 years or older ("**Entrant(s)**"). Employees of the Promoter, its related bodies corporate and its agencies associated with this Competition and their immediate families are ineligible to enter. Entry is free.

**2. Send in entries:** To enter the Competition, Entrants must submit, during the Promotional Period, a written entry via email of **30 words or less** by sharing their tip for a good night's sleep. Entrants should also include in their entry their name, address, phone number and email. No responsibility accepted for late or misdirected email. One entry per Entrant is permitted.

**3. Promotional Period:** Promotion commences 9am **11/09/17**. Entries close by 11.59pm on **12/10/18**.

**4. Selection:** This is a game of skill, and chance plays no part in determining the winners. Each entry will be individually judged, based on originality and creativity. Unless otherwise notified by the Promoter, the judging panel will consist of the Features Editor of *Inform* and an appointee of the Promoter's senior management. Judging of the entries will take place at the Promoter's offices at 1 Farrer Place, Sydney NSW 2001 and will be completed by **16/10/2018**. The winners will be notified by email by **17/10/2018** and may be published in Issue 31 of *Inform*.
